Environmental Requirements for Suppliers

1. Environmental Regulations

- (a) Sierra Wireless is committed to environmental care in all of its operations. Therefore Sierra Wireless encourages the collection and qualified recycling of Goods at the end of their useful lives, by external certified parties.
- (b) Supplier shall not put in use above the legal thresholds the forbidden substances listed in any EU and US regulations, in the Materials, Components or Process relating to the manufacture of the Goods.
- (c) Supplier shall monitor evolution of the regulations and directives. In case modification of Good(s) is needed, Supplier shall inform Sierra Wireless through "Sierra Wireless Component PCN rules for suppliers" process. Phase out plans, including a final date of use, are required.
- (d) Supplier shall organize the identification of recyclability by marking materials
 - for packing material: using the identification letter as 94/62/EC + the recycle signs as defined in DIN6120 for plastics packing
 - for plastic Goods: using the recycle signs in DIN54840 (ISO 11469) (and in accordance with all applicable additional or replacement regulations from time to time in force). A recycle sign shall be introduced for all plastic parts with a weight > 50 g.
- (e) Supplier shall organize the identification of ROHS compliancy which can be done by specific marking on the Goods, on a label, or on a separate shipping document which identifies the Goods.

2. Environmental Warranties

Supplier warrants that Goods and their packaging are in compliance with environmental laws and regulations applicable to the Good(s). This includes:

- (a) The European Directive 2011/65/EU for Restrictions of Hazardous Substances (ROHS), including amendments and modifications. In particular, (i) directive 2015/863 amending annex II shall be applied and (ii) scope and dates of applicability of the exemptions listed in Annex III shall be checked as per article 5(2)
- (b) The European Regulation 1907/2006 concerning the Registration, Evaluation, Authorization and Restrictions of Chemicals (so called and herein referred to as "REACH"), including all amendments and modifications. In particular, (i) supplied parts shall comply with the Annex XIV of REACH and (ii) the substances contained in supplied parts shall comply with the conditions of restriction defined in the Annex XVII of REACH http://echa.europa.eu/addressing-chemicals-of-concern/
- (c) The European regulation 1005/2009 on Ozone Depleting Substances amended by Regulation (EC)744/2010;
- (d) The European Directive 2006/66/EC on batteries and accumulators containing certain dangerous substances:
- (e) The European Directive 94/62/EC on packaging and packaging waste;
- (f) The European Directive 2012/19/EC on Waste of Electrical and Electronic Equipment;
- (g) The European Regulation (EC) 850/2004 on Persistent Organic Pollutants (POP) and its amendments, such as 756/2010, 757/2010 and 1342/2014; and



- (h) The Banned or Restricted Substances listed in the IEC62474 list "Criteria 1: Currently regulated".

- (i) The California's Safe Drinking Water and Toxic Enforcement Act (commonly known at Proposition 65)

3. Environmental Compliancy Report

- (a) Supplier is responsible to guarantee that its Good(s) do not contain above the legal limits any of the regulated and/or restricted substances of any of the regulations and/or directives listed in chapter 2.
 - Supplier shall provide a copy of its compliancy certificates against the regulations/directives listed in chapter 2 for all the Goods delivered to Sierra Wireless or to Sierra Wireless'EMS.
 - Use of exemption(s) shall be clearly indicated. For example, for ROHS compliancy, if the Goods use any exemption listed in Annex III, the compliancy certificate(s) shall state which exemption(s) applies. Additionally, as exemptions listed in Annex III are no longer applicable after 21 July 2016, Supplier previously using any of those exemptions shall inform Sierra Wireless of Supplier's compliancy action plan.
- (b) Usage of regulated and/or restricted substances, even if lower than threshold, shall be reported.
- (c) Supplier shall provide the material declaration for all of the Goods delivered to Sierra Wireless or to Sierra Wireless' EMS. Preferably the declaration shall be done through IMDS http://www.mdsystem.com (Sierra Wireless' IMDs number is 24914), alternatively Supplier's template can be used.
- (d) The regulated and/or restricted substances are updated on a regular basis. Supplier is therefore responsible to check after each update that the supplied Goods do not have any of the new added substances and shall inform Sierra Wireless in case a substance is present in any Good(s).
 - For example, in order to meet the requirement of the article 33(1) of REACH, Supplier shall anticipate the update of the SVHC list and check the "Submitted SVHC proposals" list (https://echa.europa.eu/registry-of-submitted-svhc-intentions, released in February and August)
 - Without notice from Supplier directly after an update of a regulation, Sierra Wireless will consider that no restricted substance(s) is/are present in the Goods shipped by Supplier to Sierra Wireless or to Sierra Wireless'EMS.
 - Example of regulation update: for Reach, update of the SVHC list or of annex XVII; for ROHS, update of the annex II or annex III; for Proposition 65, update of the List.
- (e) In case Supplier delivers Goods which contain any of the regulated and/or restricted substances of any of the regulations and/or directives listed on chapter 2, Supplier shall inform Sierra Wireless (i) upon execution of this letter, (ii) after each update of regulations.

4. Conflict Minerals Compliance Program.

(a) Supplier shall ensure that it is compliant with Sierra Wireless' Conflicts Minerals Policy, as may be amended from time to time and posted on Sierra Wireless' website on the following page:

(b) In furtherance of such policy, Supplier shall complete the "Conflict Minerals Reporting Template" (latest version) per The Electronic Industry Citizenship Coalition (EICC) and submit it to Sierra Wireless annually. Supplier may be requested to provide to Sierra Wireless, upon request, evidence of conflict free sourcing for any conflict minerals in the Goods.

5. Other substances to be reported

In case Supplier delivers Goods which contain any of the substances identified below in paragraphs (a), (b) or (c), Supplier shall inform Sierra Wireless (i) upon execution of this letter, (ii) after each update of IEC62474 or GADSL or JS-709. The same information shall be provided by Supplier when Good(s) are under evaluation by Sierra Wireless.
